  - A. Have signed a confidentiality agreement in the version prepared by Saint-Gobain Glass Polska, which is made available by the contact person named in item 10 of this announcement.
  - B. Have appropriate certificate of being registered in the record of business entities, issued not earlier than 6 months before the deadline for submitting the tenders.
  - C. Possess indispensable knowledge and experience as well as documented performance of similar orders together with references.

- D. Are in a financial and business condition that allows performance of the order and fulfil the following criteria:
  - Employment as of 30<sup>th</sup> June 2005: minimum 10 persons,
  - Sales in the year 2004: minimum 5,000,000 PLN,
- E. Have submitted information from the bank where they have their principal bank account confirming the amount of possessed financial means or their credit worthiness – issued not earlier than 6 months before the deadline for submitting the tenders.
- F. Have insured their business activities against third-party damages for a sum not less than 500,000 PLN, and have presented an insurance policy or some other insurance document confirming that the contractor is insured within its business activities against third-party damages.
- G. Have submitted their tenders in writing before the deadline determined in item 6 of this announcement.

- Financial security – 20%
- Technical quality – 20%
